### **APPROVAL OF AGENDA:**

**PUBLIC COMMENT PERIOD:** No members of the public were in attendance. Mr. Gibson asked Ms. Morse if she had a message from congressman Emmer's office. Ms. Morse said they have received some community funding requests that they have put forth (15<sup>th</sup> Street north extension in Sartell and Heather Wood Road improvements in Saint Cloud). Ms. Morse noted her office is happy to look at any grants and is attending the policy board meeting to pass on information regarding community needs to her office.

# **Presentation on FY 2021 Budget Performance**

Mr. Gibson summarized the 2021 expenditures. The largest expenditure was the regional household travel survey (29% of budget). The Mississippi River Bridge Study that began in 2020 is expected to wrap up in 2022. Mr. Perske asked the City of Saint Cloud board members about their thoughts on the Mississippi River Bridge Study and if anyone knows about this project on a state level. Mr. Masters asked if there was an estimated cost on the project. Mr. Georger said around \$100 million and he agreed that the project needs to get recognized on the state level and is important. Mr. Conway said they need to find a way to bypass 23 going through town and find a different way to connect. Mr. Gapinski added that 29 would connect Sartell to 10 and provide movement on the beltway. Ms. Danielowski added that to get someone from the upper levels of MnDOT would be important. Mr. Gibson summarized the 2021 revenue. Mr. Gibson summarized the financial assets declining each year since 2018 by design so that there is not too much in savings. Mr. Gibson felt \$400,000-\$500,000 is a good amount to keep in financial assets. Mr. Gibson reviewed budget vs expended costs. Mr. Gibson noted low interest rates have limited interest income. Estimates for future income should better consider the overall economic environment. Going forward MnDOT will establish a performance measure for MPOs to expend at least 90% of the Saint Cloud APO CPG budget. Mid-year adjustments may become more common to help ensure we hit our target budget.
