FY 2024-2027 Transportation Improvement Program Amendments February – April 2024

The following is a detailed list of proposed changes to the Saint Cloud Area Planning Organization's (APO's) fiscal years (FY) 2024-2027 Transportation Improvement Program (TIP). Given the nature of some of these changes, an amendment process to this document has been initiated. Per guidelines documented in the APO's Stakeholder Engagement Plan (SEP), a 30-day public comment period is required before changes can be implemented.

Public comment on these requested changes will run from Wednesday, Feb. 14, 2024, through Friday, March 15, 2024. Comments can be made via email (ikeogu@stcloudapo.org), phone (320-252-7568), or via mail (1040 County Road 4, St. Cloud, MN 56303).

The APO's Technical Advisory Committee (TAC) – a committee of area planners and engineers – will review these changes at its special meeting on March 28, 2024. The APO's Policy Board is anticipated to act on these changes at its regularly scheduled April meeting (April 11, 2024).

MnDOT District 3 staff have initiated a funding swap between the City of Sauk Rapids and Sherburne County. Sauk Rapids will no longer be advance constructing this project and will instead receive the Federal funding in 2024. No advance construction needed.
