

## FY 2024-2027 Transportation Improvement Program Amendments July-August 2024

The following is a detailed list of proposed changes to the Saint Cloud Area Planning Organization's (APO's) fiscal years (FY) 2024-2027 Transportation Improvement Program (TIP). Given the nature of some of these changes, an amendment process to this document has been initiated. Per guidelines documented in the APO's Stakeholder Engagement Plan (SEP), a 30-day public comment period is required before changes can be implemented.
