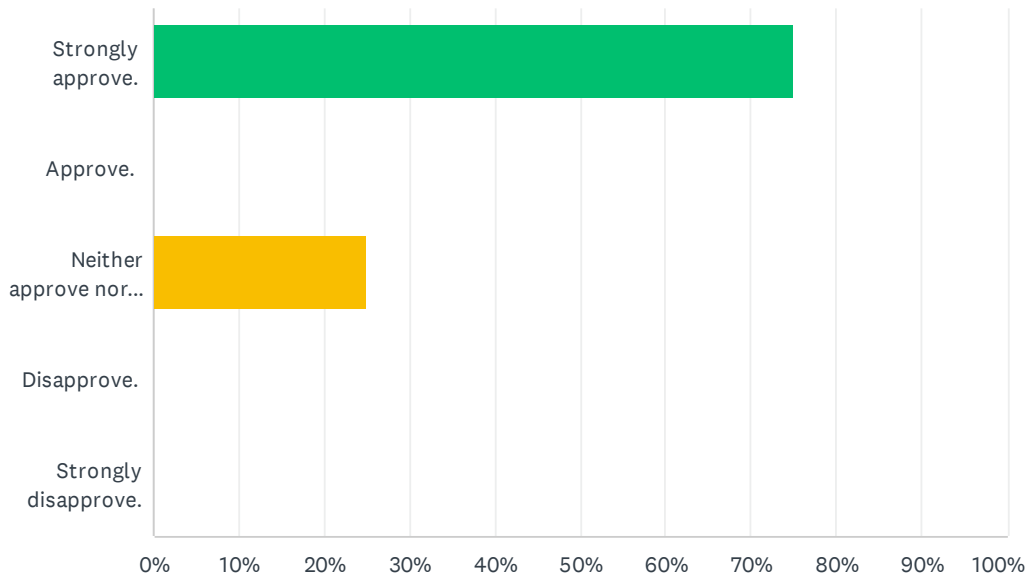


Q1 Due to an increase in funding due to the Infrastructure Investment and Jobs Act (IIJA), additional Transportation Alternatives (TA) funding -- the program that provided Federal funding assistance for this project -- was made available. Rather than having the city wait for reimbursement in 2025, the Central Minnesota Area Transportation Partnership (ATP-3) is recommending MOVING the Federal funding to fiscal year 2023. Thus, this project will be fully funded in 2023. No changes to the estimated project cost of \$458,740 is anticipated at this time. How do you feel about this proposed change?

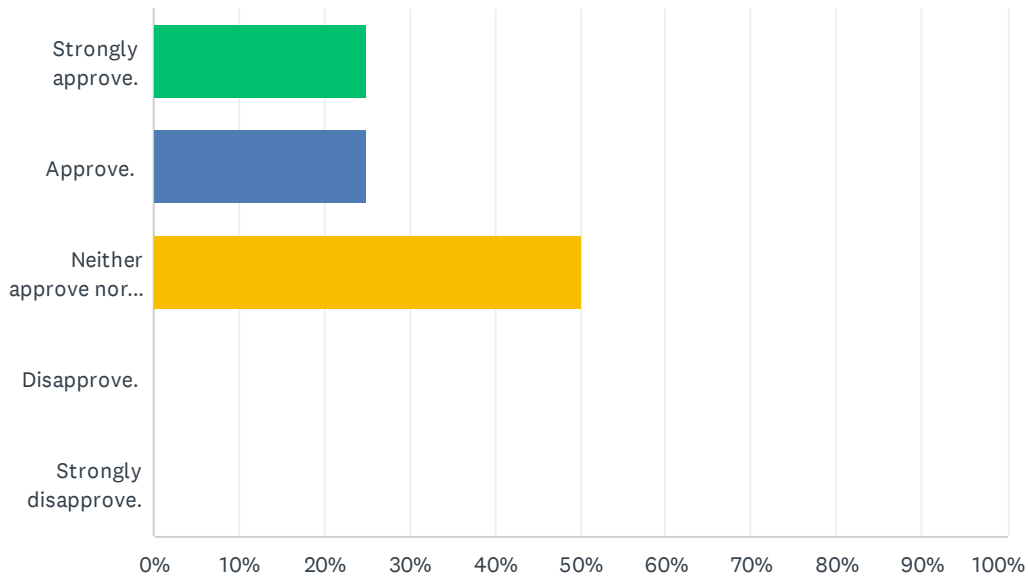

Q2 Saint Cloud Metro Bus is currently has a \$4 million project programmed into the FY 2023-2026 TIP for its western transit center. Of that, \$2 million is funded with state bonding funding, \$1.2 million is funded with state funding, and \$800,000 is funded with local funding. Per discussions with MnDOT's Office of Transit and Active Transportation (OTAT), the state is requesting to SWAP Federal funding for state funding for this project. This will result in the \$1.2 million coming from Federal rather than state funding. The estimated project cost is not anticipated to change at this time. How do you feel about this proposed change?

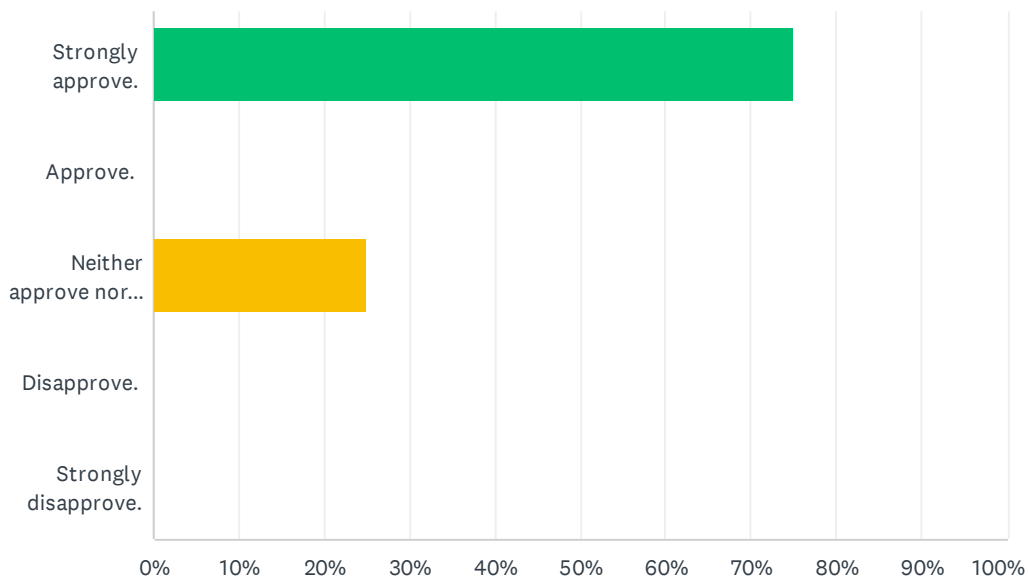

Q3 Due to the influx in Transportation Alternatives (TA) funding -- the program that provided federal funding for this project -- Stearns County is hoping to receive an ADDITIONAL \$135,090 in Federal funding to complete this project. This action was recommended by the Central Minnesota Area Transportation Partnership (ATP-3) to: 1) spend the remaining FY 2023 funds available to the ATP-3 and 2) to get Stearns County closer to the ideal 80/20 split (80% Federal funding / 20% local funding). This will INCREASE the amount of Federal funding from \$427,106 to \$562,196 and DECREASE the amount of local funding from \$797,894 to \$662,804. How do you feel about this proposed change?

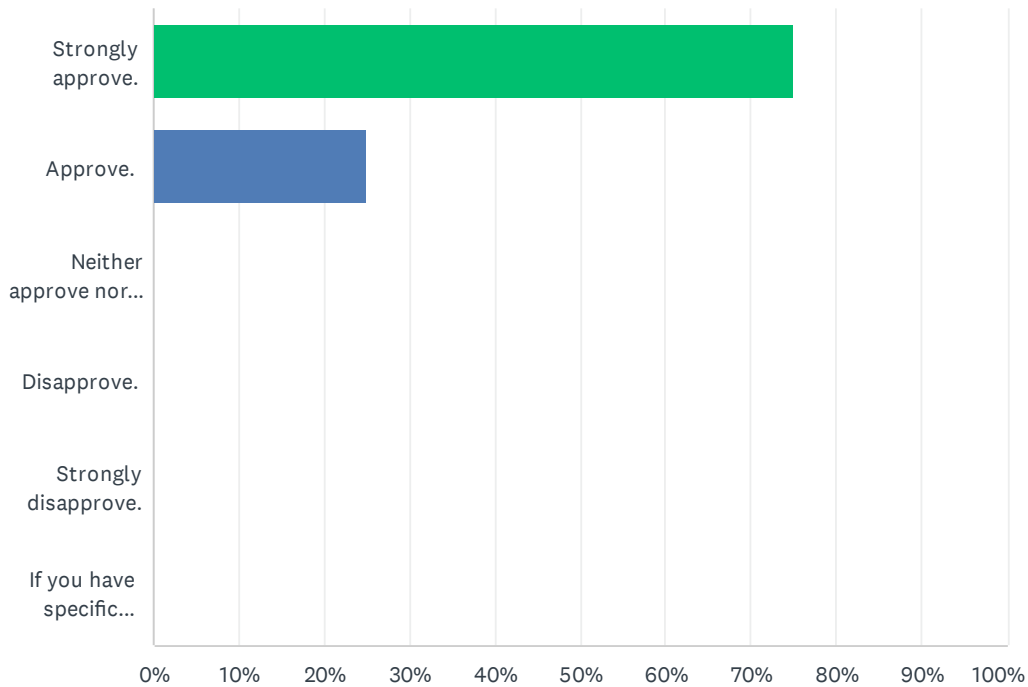

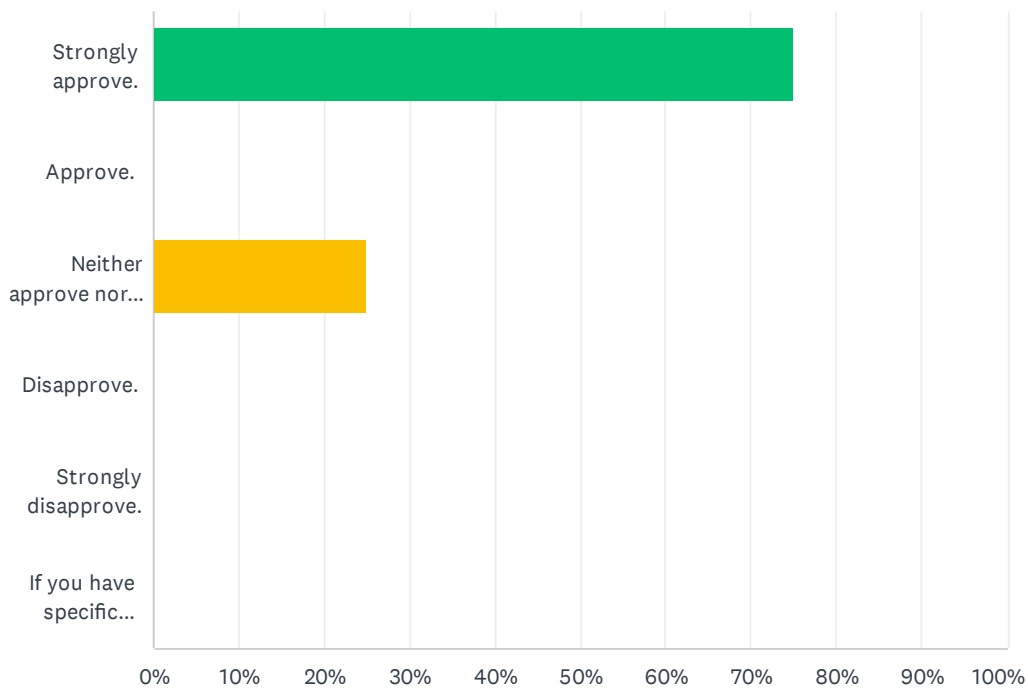

Q5 Due to an increase in funding as a result of the Infrastructure Investment and Jobs Act (IIJA), Stearns County is requesting the advance construction payback for this project be adjusted. Instead of having Federal funding paid back in both 2023 (\$520,000) and 2024 (\$292,270), the Central Minnesota Area Transportation Partnership (ATP-3) is proposing to have all the Federal funding MOVED UP to FY 2023 (\$812,270). This means Stearns County would not have to wait until 2024 to receive its final reimbursement. No changes to the estimated project cost of \$,1813,000 are anticipated at this time. 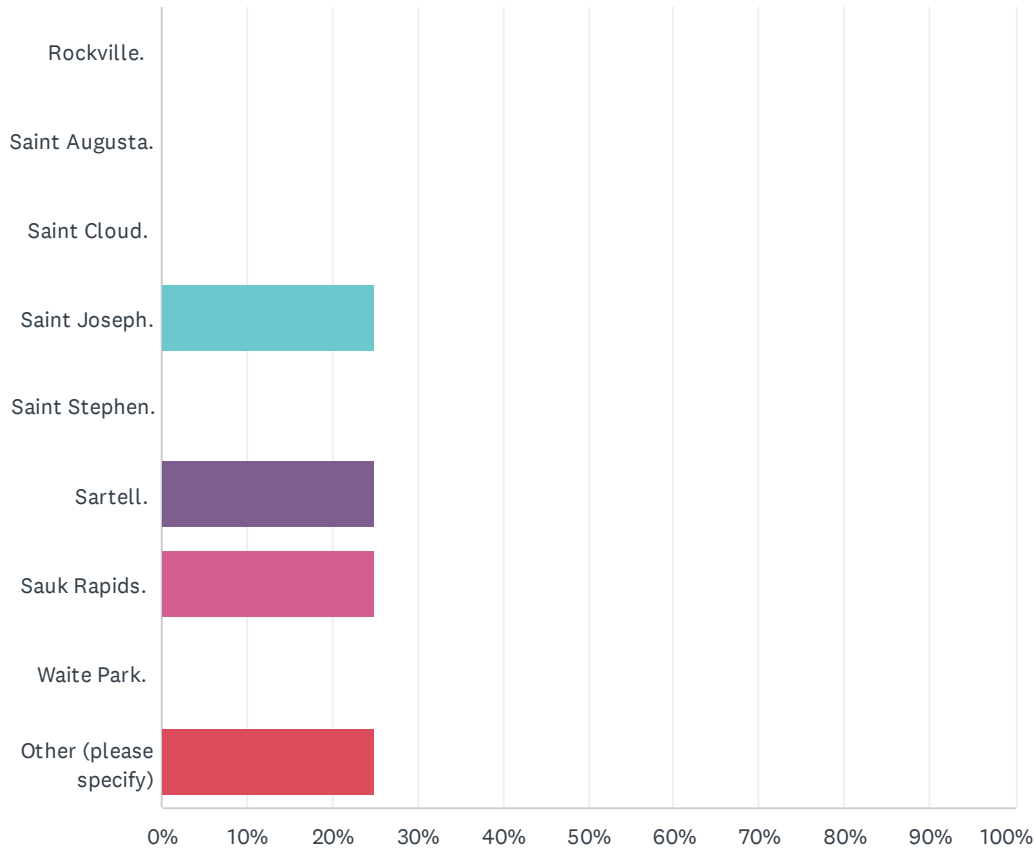

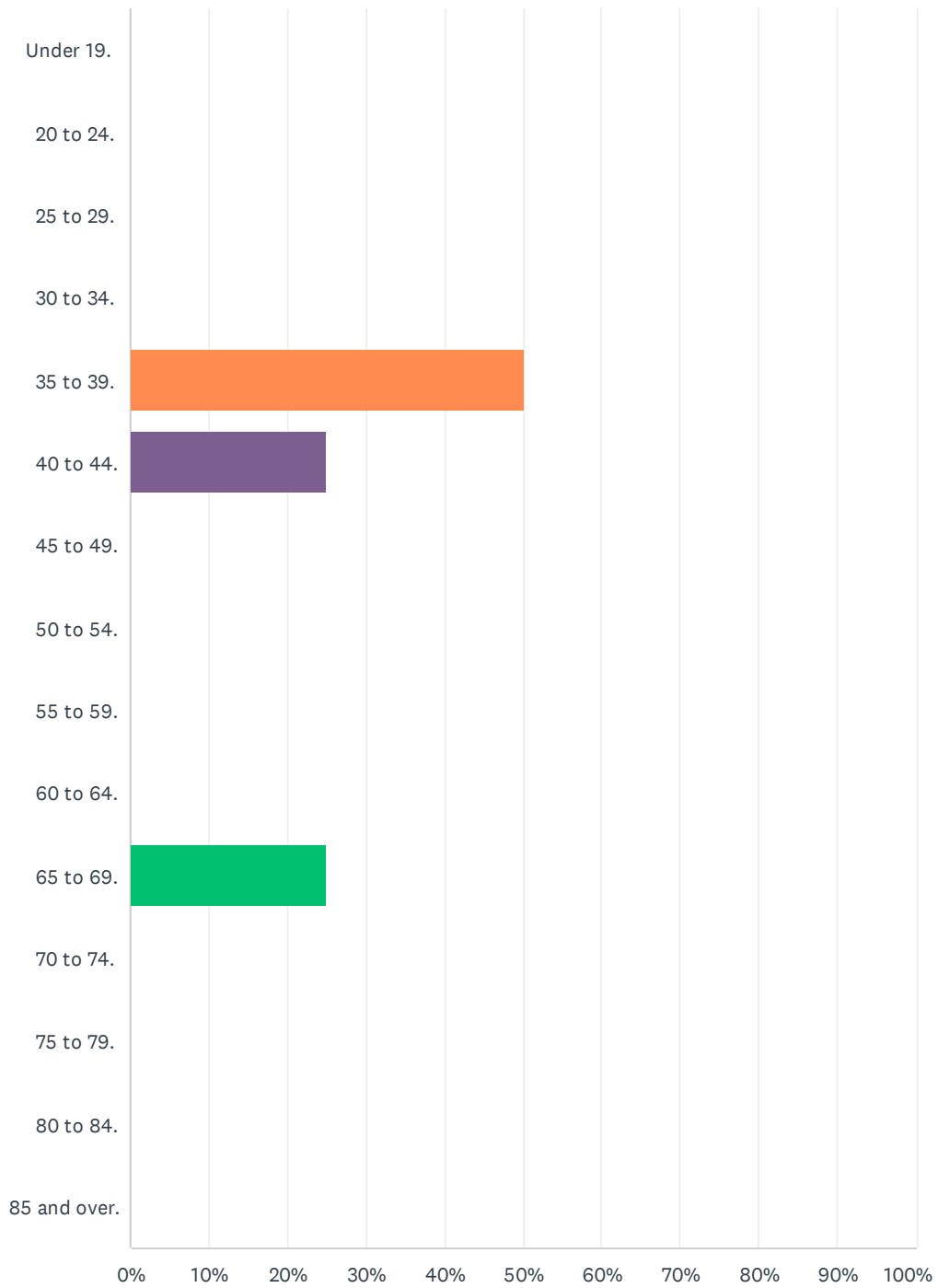

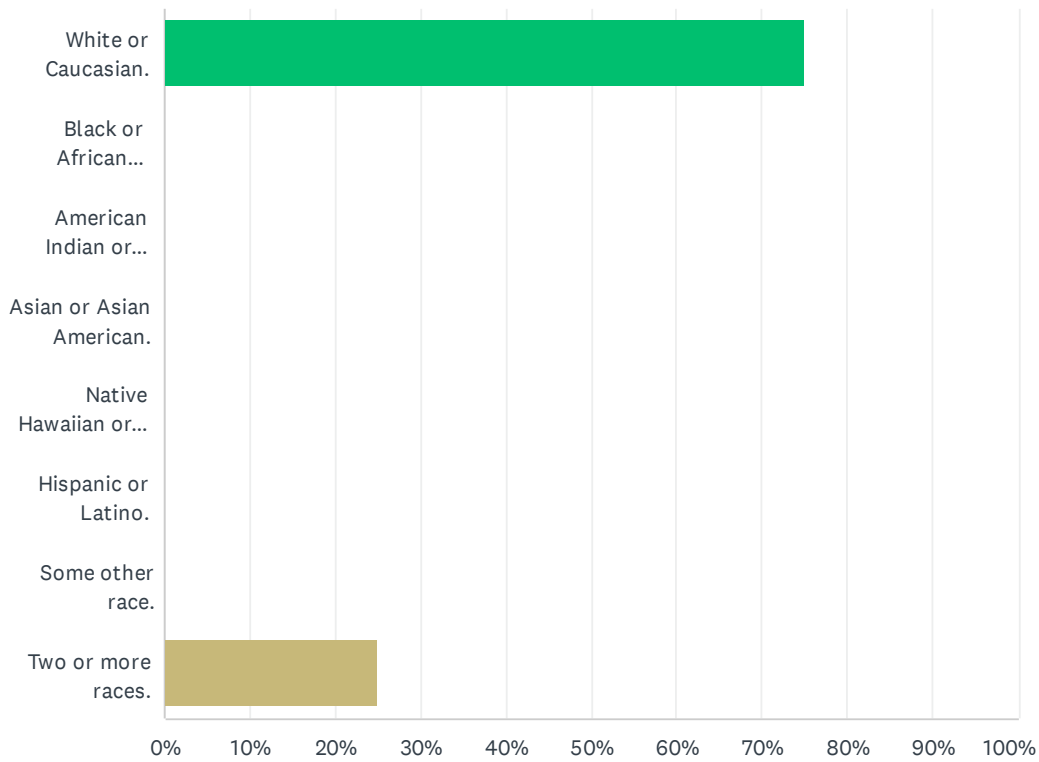

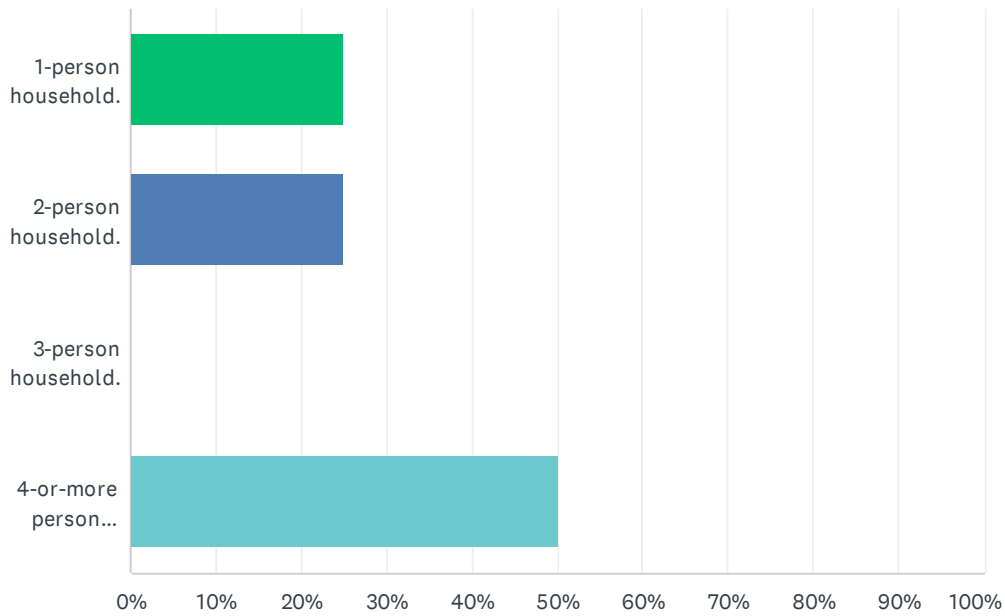

Q13 How many people live in your household?

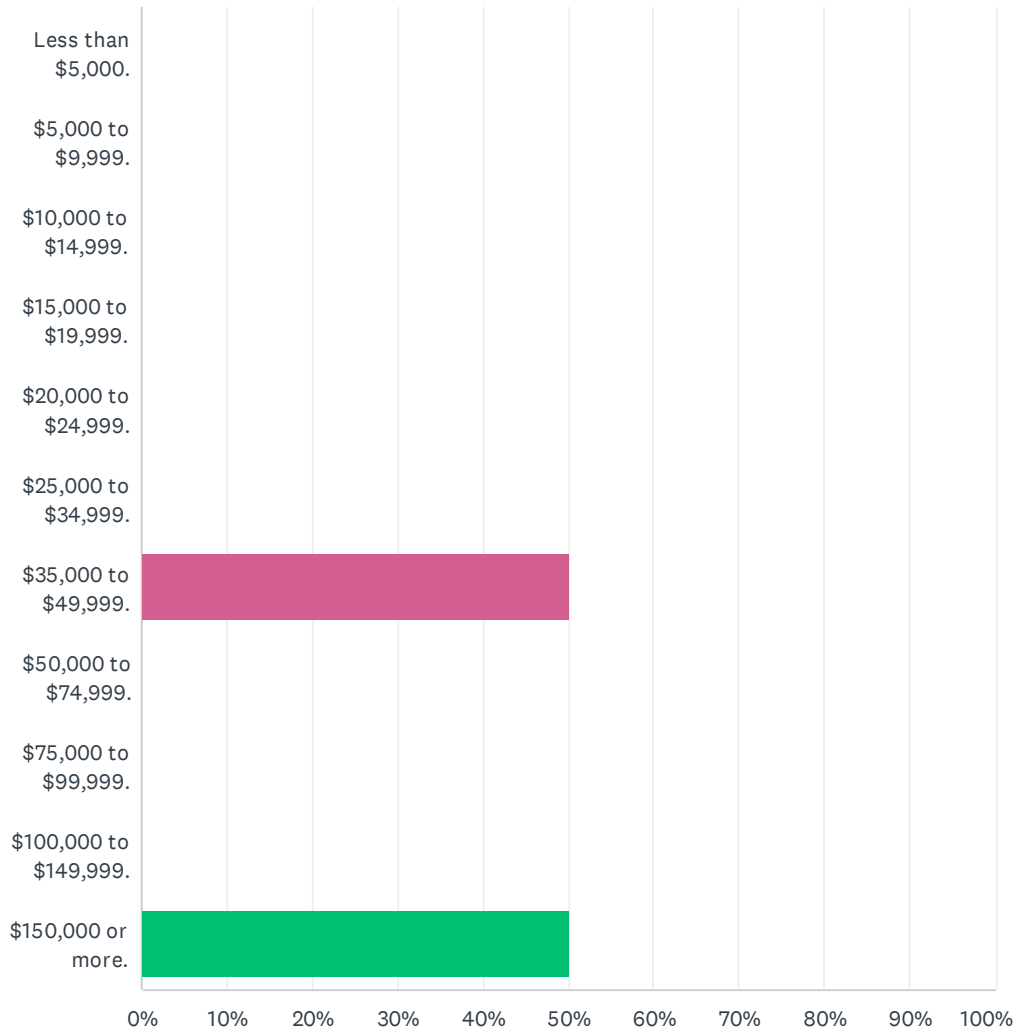

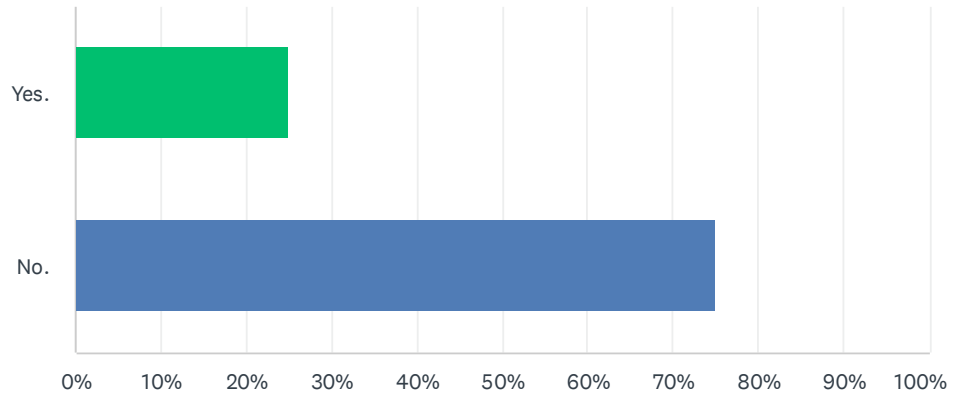

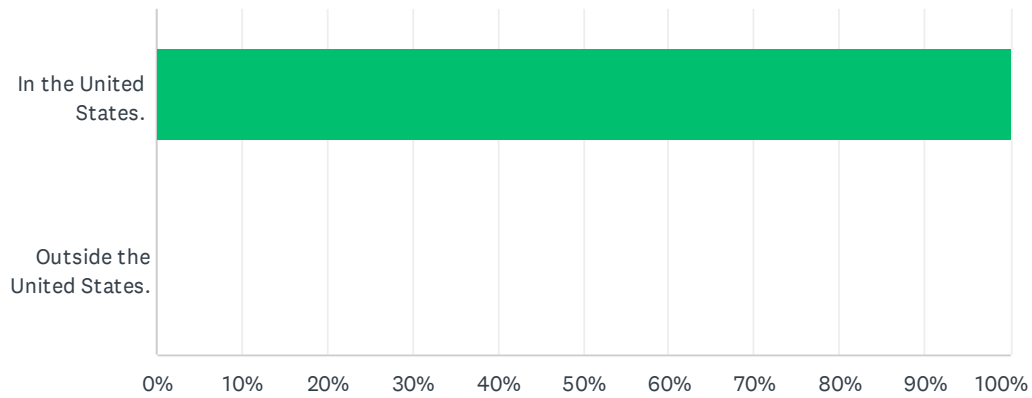

Q16 Where were you born?

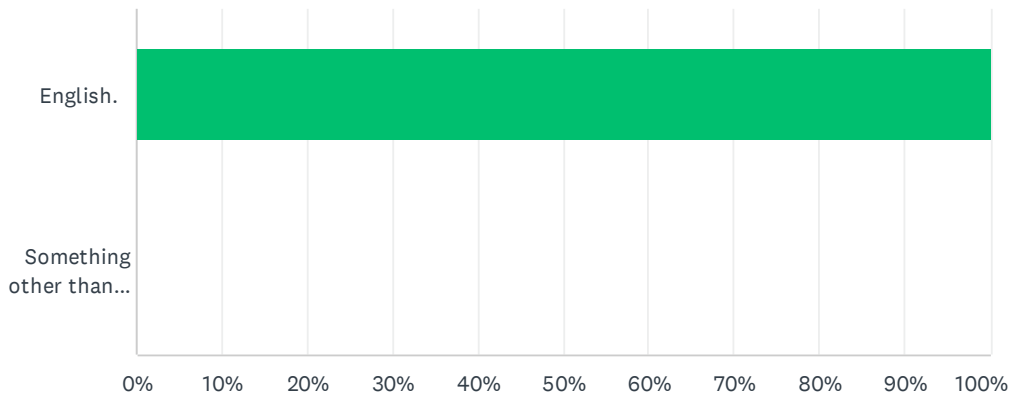
